# **PROPOSAL NO. 15**

### **Department Structure**

November 30, 2023

(The Union reserves the right to modify or withdraw any of the following proposals during bargaining. These proposals are made without prejudice to the Union's position regarding the proper interpretation of the existing contract language or existing practices or policies. All proposals are part of a complete package, and no agreements reached during bargaining are final until agreement has been reached on all issues.)

All Union proposals remain unchanged except as provided below. All Union responses to Company proposals remain unchanged except as modified below.

### Job Security

Hold seniority window/band proposals and out-of-seniority severance pay pending outcome of department structure discussions.

#### Response to Company proposal 11, Department List:

In order to provide unit members with the appropriate level of job protection based on their length of service, the definition of a "Department" in the contract will be modified as follows:

### **ARTICLE VI – JOB SECURITY**

K. "Department" for purposes of this Article means the area of the Company in which the Employee in question works and which has been designated by the Company <u>and approved by the union</u> as a distinct functional/operational group. The names of such departments and the employees in each will be included in periodic reports provided to the union and may be updated in advance of any layoffs.

The union accepts the company's proposed department "mergers" as presented in its Nov. 9 proposal No. 11 with the following exceptions:
